## Notes:

- 1. The Standalone results for the Quarter Ended 30 June 2019 were reviewed and recommended by the Audit Committee and approved by the Board of Directors at their respective meetings held on August 10, 2019.
- 2. For the amount of Rs. 18,335.13 lakhs advanced to a related party for purchase of land, which was called back by the company since the shareholders have not approved the same, the company has charged interest of Rs. 822.82 lakhs during the quarter (June 30, 2018 :Rs.822.82 lakhs)
- 3. The company has charged interest of Rs. 224.38 lakhs for the quarter (June 30, 2018: 224.38 lakhs) on the amount of Rs. 6,000.00 lakhs advanced to the related party towards windmill purchase which was cancelled later.
- 4. Ind AS 116 " Leases", has been recently introduced effective April 01,2019, and its application did not have any significant impact on recognition and measurement of leases in the financial results including the retained earnings as at April 01, 2019.
- 5.In accordance with Ind AS 108 on "Operating Segments", the company operates in one business segment viz. Real Estate business and hence segment information is not required to be furnished.
- 6. The figures for the quarter ended March 31, 2019 are the balancing figures between audited figures for the full financial year ended March 31, 2019 and nine months unaudited published figures up to December 31, 2018.
- 7. Previous period's figures have been regrouped/recast, wherever necessary, to conform to the classification on the current period's classification.
